



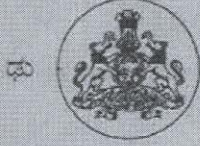

AND WHEREAS the SETTLOR is aware that Hindi is the National Language of India and has observed that the Hindi speaking population in the states of Karnataka, Andhra Pradesh, Tamil Nadu, and Kerala are in minority. The Hindi speaking migrant population in these states needs an avenue to continue to speak Hindi, and also educate their young ones in Hindi so that their language, customs and traditions are not lost.

AND WHEREAS, in view of the foregone the SETTLOR is desirous of making a public charitable Trust of the said sum in order to render and provide philanthropic and educational services for Hindi speaking minority population in the states of Karnataka, Andhra Pradesh, Tamil Nadu, and Kerala.

AND WHEREAS the trustees are willing to accept the office and the duties and obligations on their part and to be invested with the ownership of the trust fund for the purpose of carrying on the objective of the said trust set forth therein.

AND WHEREAS the said sum has in anticipation of these presents been already transferred, paid and handed over to the Trustees before the execution of these presents.

NOW THIS DEED WITNESS AS FOLLOWS:

1. The name of the trust shall be "NATURE'S ACADEMY OF EDUCATION".
2. The registered office of the Trust shall be situated at Flat No. SIG 806, Golden Blossom Apartment, Kudogodi, Bangalore - 560 067, Karnataka or such other place as the Trustees may from time to time decide. The Trust may also carry on its work at any other place or places, as decided by the Trustees to achieve its objectives.
3. The Trustees shall hold the sum of Rs. 1,000/- (Rupees One thousand only) this day paid to them and all monies may herein after be received by the trustees from time as gifts, donations or subscription or otherwise (all such sums of property moveable or immovable are hereinafter include in the expressions of trust fund) for the purposes of the trust and the trust fund shall vest in the trustees jointly.
4. The objects of the trust are:-
 - a) The Education object shall include:
 - i. To render and provide philanthropic and educational services for Hindi speaking minority population in the states of Karnataka, Andhra Pradesh, Tamil Nadu, and Kerala.
 - ii. To encourage and promote the Hindi speaking minority population in the states of Karnataka, Andhra Pradesh, Tamil Nadu, and Kerala to learn and speak their native tongue more precisely to ensure that their language, customs and traditions are not lost.

- iii. To promote education, science, literature, fine arts, sports, technical and vocational training and skills amongst youngsters belonging to linguistic minority (Hindi) communities in the states of Karnataka, Andhra Pradesh, Tamil Nadu, and Kerala; and thus sub serving the interest of the minority community.
- iv. To create awareness about the importance, and encourage the study and use of Hindi and Sanskrit languages.
- v. To establish, open, own, run, administer, acquire, take over and continue educational institutions including but not limited to child care, pre nursery, primary, middle and high schools, colleges for various educational, needs like degree in science, commerce, management, medical colleges, vocational training institutes, engineering educational institutions like vocational, ITI, diploma courses and engineering colleges for the sole benefit of linguistic minority (Hindi) communities in the states of Karnataka, Andhra Pradesh, Tamil Nadu, and Kerala. Meritorious students of other communities and religions may also be admit subject to the prevalent laws,
- vi. To establish open, own, run, administer, acquire, take over and continue educational training and research institutions in technology, management, computer science, Engineering colleges, Medical Institutions, Hospitals, Community Halls, Science and Arts in order to promote technical and general education among the people of linguistic minority (Hindi) communities in the states of Karnataka, Andhra Pradesh, Tamil Nadu, and Kerala; and thus sub serving the interest of the minority community.
- vii. To engage teachers, professors, instructors and experts of good moral character and capable to impart efficiently up-to-date instruction in Hindi, English and other languages to pupils and students in various pursuits in the field of modern sciences, Agricultural and industrial vocations, research and development and other work of intellectual pursuit.
- viii. To encourage and publish books, journals, magazines, white papers, newsletters etc. in Hindi and other Language using print and / or electronic media for circulation in India as well as abroad.







- ix. To organize and conduct conferences, lectures, workshops, seminars, special classes, competitions, exhibitions etc. for the promotion of Hindi language.
- x. To provide educational opportunity for non-minority members to learn a new language - Hindi.
- xi. To preserve and develop the ancient art, culture and shastras of India in Hindi Language; and to support, encourage and help institutions and individuals who are engaged in preservation and promotion of Hindi Language and text or to take over of the management of such institutions.
- xii. To bring out, encourage and develop the inventive and research faculties of the pupils and the teachers and to afford opportunity for research work in the field of Hindi language, education, science, literature, fine arts, sports, technical and vocational training and skills.
- xiii. To own, establish, take over, acquire, run, administer, manage, assist and maintain, in India and abroad, any research & development institution in any field of art, science, culture, education, vocation, law, social, religious, medicine; or to do any act which is consistent with this objective.
- xiv. To undertake and coordinate research, and to provide a platform for sharing ideas and research findings and to build network among individuals /institutions.
- xv. To join hands with other associations, organizations or institutions that have similar objectives.
- xvi. To establish, operate, maintain, libraries, translation hub, pool of translators using Hindi Language.
- xvii. To develop a healthy as well as critical attitude towards the development and mental, physical and moral uplift of the minority students and all those connected with the institution so as to make them good citizens.

- xxiv. To award scholarships / financial aid to meritorious and / or deserving students belonging to Hindi speaking minority community for studies in India or abroad.
- xxv. To acquire real estate for the purpose of achieving the aforementioned purposes.
- xxvi. To do all such other acts that may be incidental or consequential to any of the foregoing purposes.

b) Other objects of general public utility -

- i. To acquire property for the sole use for public good by making it available for public purposes as for example, housing a library clinic, crèche, and/or as a community hall to be available for public use as training classes, seminars, discourses and other public functions for benefit of the community in general.
- ii. To make donation / contribution to other non-profit organisations having similar objectives.
- iii. To render financial, or any other kind of assistance to staff and / or any other person in need.
- iv. To set-up or facilitate incubation centres.

- v. To open job-oriented service centres in order to help generate the requisite talent pool required in the industry from time to time.
- vi. To apply for registration, renew, and protect all intellectual property rights created or acquired by the TRUST.
- vii. To undertake any other activity incidental to the above activities but which are not inconsistent with the above objects.

5. Beneficiary Clause: The benefits of the Trust shall be open to all irrespective of caste, creed, sex or religion.

6. The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, Government, Local authorities, any other charitable institutions, or private institution etc in cash or in kind including immovable property without any encumbrance, but the Trustees shall not accept any receipt with any condition or terms inconsistent with the objects of the Trusts. While applying such receipts to the objects, the Trustees shall respect the directions, if any, by the grantor. Any receipt with specific direction to treat the same as part of the corpus of the Trust or separate fund shall be funded accordingly.

7. The trustees shall have the absolute right to the management and control over the trust fund and money; and from time to time, to make such regulations (not being inconsistent with this deed) as they may think fit and necessary for the purpose of such management and control or in connection with the execution of any of the rights herein contained or powers hereby vested in them and may rescind or alter any such regulations. However in case of there being any dispute among the principal trustees, for the furtherance and achievement of the objects of the trust in totality, it is here by decided in the better interest of the trust that the chairmen and any one other principal trustee's decision in all such matters shall be final and binding notwithstanding any clause mentioned anywhere in this document.

8. In particular and without prejudice to the generality of the foregoing provision, the trustees shall have the following powers, namely :-

- i. To appoint a managing Trustee, when necessary. However, initially Mr. Mukesh Kumar Singh shall be the Managing Trustee.

- ii. To review the affairs of the Trust as and when necessary.
- iii. To appoint officers or members of the staff for the Trust and to prescribe their conditions of the service.
- iv. To operate and to provide for operating banking accounts
- v. To raise loans with or without security or to invite donations.
- vi. To authorize persons to sign or execute documents on behalf of the trust.
- vii. To grant receipts for aid or donations received.
- viii. To grant special power of attorney authorising any persons to represent the Trustees in connection with any legal or other proceedings.
- ix. To invest money or asset of the said trust in approved securities including debentures of the joint stock companies, shares and securities of public or private corporate basis.
- x. To acquire land or building on lease or by way of purchase, and may also at any time sell or otherwise dispose of any such property; all money arising from any such sale or other disposition as aforesaid shall become and be deemed to be part of the trust fund and shall be applied for the purpose of the trust.
- xi. To compromise, compound or refer to arbitrations all actions, proceedings and disputes relating to Trust property.
- xii. To seek legal opinion of lawyers and/or Chartered Accountants as and when required;
- xiii. To vote at meetings of the Board of Trustees, subject to the veto power of the Chairman.

9. Utilization clause: The Trustees may apply any part of the trust funds, all profits and income of the trust, whatsoever and howsoever derived, shall be utilized solely for the furtherance of the objects of the trust including and not limited to acquiring by purchase or on lease or otherwise, of land, building, machinery, furniture, or other movable or immovable property; as they may deem necessary or expedient and may also at any time sell or otherwise dispose of any such property; all money arising from any such sale or other disposition as aforesaid shall become and be deemed to be part of the trust fund and shall be applied for the purpose of the trust; and shall not be distributed among the trustees or any other persons.
10. The Trustees may from time to time or at any time appointment on such terms and conditions as they may determine a secretary, Manager and any other member of the staff for carrying out the activities of the Trust and may at any time remove any such secretary, manager or member of the staff.
11. The trustees may from time to time appoint suitable Committees, sub committees with members who have expertise and or experience in the area of art, science, culture, education, vocation, law, social, religious, medicine, etc. and the roles benefits and obligations of the subcommittee members can be decided by the Trust from time to time. The nomenclature of such sub committees and the nature of the working of the sub committees can be decided by the trust from time to time
12. The trustees may from time to time nominate suitable person(s) who have expertise in the area of art, science, culture, education, vocation, law, social, religious, medicine, etc. as mentors, and the roles benefits and obligations of the mentors can be decided by the Trustees from time to time.
13. After defraying all necessary expenses incurred in the collection or realization of the income from the trust fund, reserve fund, to be utilized when in the option of the trustees, there is any emergency and the remaining income may be utilized for the purpose of the Trust
14. Bank Account: That the Trustees may by resolutions authorize any trustee, officer or employee of the trust to open maintain and operate an account in such bank as they may decide from time to time. Further for the purpose of better convenience and proper accountability it is decided that the chairmen of the trust along with one of the trustees will have the joint bank mandate (limited to chairmen along with one trustee only) and the same shall be conveyed to the appropriate persons by way of a trust resolution.
15. Accounts Clause: There shall be maintained all accounts of the Trust regularly. The account shall be duly audited by a qualified Chartered Accountant every year. The accounts shall be closed every year by 31st March for financial Reporting purposes.

16. Investment Clause: The Trustees as they shall deem expedient shall invest the trust fund in government securities, saving certificates, fixed deposits or in any of the forms of the investment authorized under provisions of Indian Trust Act and Indian Income-Tax Act, 1961, and section 13(1) (d) read with section 11(5) of the IT Act 1961 as amended from time to time.
17. That the Trustees may donate, give, lend, or contribute in any manner as it deems fit, a portion of the Trust Fund to some other Charitable Trust or Non-Profit Organization having similar aims and objects.
18. That the Trustee may when they deem fit in order to meet the objects of the Trust collaborate with any other Charitable or Non-Profit Organisation having similar aims and objects. Such collaboration may be financial or non-financial in nature.
19. That the Trustee may when they deem fit in order to meet the objects of the Trust take over, absorb, and / or amalgamate with any other Charitable or Non-Profit Organisation having similar aims and objects.
20. Dissolution/ winding up Clause: In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution / winding up shall under no circumstances be distributed among the trustees but the same shall be transferred to another trust, society, non-profit charitable organisation whose objects are similar to those of the Trust and which enjoys recognition under section 80G of the IT Act, 1961 as amended from time to time.
21. That the Trustee may undertake all such other lawful activities, as they may consider conducive to the attainment of the aims and objects of the Trust.
22. All questions relating to the management of the Trust or the exercise of the powers vested in the Trust, shall be decided at a meeting or if necessary and expedient by a majority of the trustees present and voting in any meeting of the trust or by circulation, as the case may be and any action or decision of such majority shall be as valid as if it was done or made by all the trustees. The chairman shall have a casting vote.

26. In case of the occurrence of any vacancy amongst the trustees by reason of death, resignation or incapacity of any trustee or for any reason whatsoever, a new trustee may be appointed to fill up the vacancy.
27. The Trustee may be paid remuneration as decided and deemed fit by the Board of Trustees.
28. Chairman: Mr. B Balakrishna Reddy shall be the first chairman of the TRUST. In the event, the Chairman becomes unable or unwilling to serve for whatsoever reasons, he shall be succeeded by a person duly nominated by him in writing. Such nomination shall be final and undisputable.
29. No trustee shall be responsible or liable for any loss or any act of omission or commission by his constituted attorney or agent or employees or other trustees unless occasioned by his willful neglect or default.
30. The Trust is irrevocable.
